This afternoon visit the 9/11 Memorial, a tribute of remembrance to the victims & events 9/11. Next, travel to the top of One World Trade Center Observation Deck for stunning views of the New York City Skyline. This evening is at leisure to enjoy the wonders of the "Big Apple" on your own.

DAY 4: NEW YORK CITY - HUDSON VALLEY - WEST POINT - BOSCOBEL

Depart New York City and begin your journey to the scenic **Hudson Valley**, which extends 150 miles above the tip of Manhattan and is designated as a National Heritage Area steeped in history, natural beauty and culture. Visit the famous and historic **U.S. Military Academy at West Point****, the oldest military academy in the country. Later visit the historic and scenic **Boscobel House & Gardens**, the 1808

house is located in the heart of the Hudson Valley and is widely regarded as one of the finest examples of Federal period architecture, furniture and decorative arts. Late afternoon check into your Hudson Valley area property for a 3-night stay.

Enjoy a tour of the well preserved estate featuring the home, museum, library and graves of Franklin & Eleanor. This afternoon visit and tour a **Maple Syrup Farm**, a state-of-the-art sugar house where you'll trace the miles-long journey of organic maple sap from tree to barrel. The popular sweet tour culminates with a tasting and a view into the bottling and sugar making operation.

Relax and enjoy clear views of historic Hudson River lighthouses, waterfront mansions and other notable locations on this sightseeing cruise. Tonight enjoy a **Farewell Dinner** with your fellow travelers at a popular local restaurant.
